Overview

Court of Chancery Rule 3(b) requires that filers submit a Supplemental Information Sheet with all new civil actions. The Supplemental Information Sheet aids case assignments and court administration; it is not a binding court admission. Still, except in the case of self-represented litigants, the court requires that an attorney review and authorize the contents of a Supplemental Information Sheet.

Effective September 15, 2025, filers will no longer be permitted to upload a file when submitting a Supplemental Information Sheet. Instead, they will be prompted to complete an online form. This form will appear when a filer selects the "Supplemental Information Sheet" document type. Once the filer fills in the form, File & ServeXpress ("FSX") will create a document containing the inputs.

The online form contains many of the same fields as the prior Supplemental Information Sheet but replaces some of the fields with drop down menus. And the court no longer requires filers to submit a statement of good cause on whether the new action should be assigned to a Magistrate in the first instance.

This manual contains step-by-step instructions on how to use the online form. Step one instructs filers on how to open the form. Step two seeks substantive information about the action under the heading "Case Information." Step three seeks information about plaintiffs' counsel, if any. Step four asks about related matters. Step five asks the bases for subject matter jurisdiction. Step six seeks information about whether the case is summary or expedited. Step seven explains how to finalize the form, edit its contents, and preview the document before filing.

This user guide attaches a sample with a complete list of dropdown options for filers to use when preparing their filing. It also attaches a sample Supplemental Information Sheet automatically generated by FSX.

Note that the instructions in this manual pertain to electronic filings by attorneys or self-represented litigants. For self-represented litigants filing in person, the Register in Chancery will continue to provide guidance at the time of filing on how to complete and upload the Supplemental Information Sheet.



Step 1: Select the Supplemental Information Sheet document type.

The online form pops up once a filer selects the Supplemental Information Sheet option from the Document Type drop-down. Once selected, the document upload option will disappear, and a form user interface will open.

Document Title: Complaint

Step 2: Provide requested case information.

Step 2(a): Provide a brief description of the case.

Under the “Case Information” heading, the first prompt asks for a “brief description of the claims asserted.” This is not new. The purpose of this information is to provide the court and support staff with a plain language explanation of what the case is about in the view of the authorizing attorney or self-represented litigant. Filers are limited to 800 characters.

Step 2(b): Identify the primary and any additional case types.

Under the “Case Information” heading, the form will identify the “primary case type.” But filers will have already selected the primary case type from the Case Tab dropdown menu in the new case filing flow. The selection will auto-populate



into the Supplemental Information Sheet once the filer submits the form. Filers are encouraged to go back and check what they selected to make sure it is an accurate description of the primary case type. Also under the “Case Information” heading, filers will be asked to select any case types in addition to the primary case type that apply. Below is a complete list of case types.

Requiring filers to select a primary case type is not new. But the court is now using that selection for case assignment purposes. The selected primary case type will presumptively determine how the court assigns the case among its judicial officers. So, filers are asked to please take care in making sure that the selection is accurate.

In many cases, multiple case types will apply. For example, an action to enforce restrictive covenants in an alternative entity agreement could accurately be described as Restrictive Covenant or Trade Secret Dispute, Other Alternative Entity Action, and Breach of Contract, depending on the circumstances of the case. When selecting the primary case type, filers should choose the case type that the authorizing attorney believes best describes the case. The other options should be selected as additional case types.

Here is the list of case types. Most of the descriptions are self-explanatory. For more information concerning the category called “Routine Petition,” see the court’s August 25, 2025, press release available at <https://courts.delaware.gov/Forms/Download.aspx?id=303378>.

Step 2(c): Indicate if the action seeks monetary relief under a transaction agreement.

The last input under the “Case Information” heading is a check-the-box option. Filers are prompted to check a box if the case seeks monetary relief (even if secondary or in the alternative) under a transaction agreement. The purpose of this field is to



flag the case for the Chancellor's review to determine whether the action may be assigned to a judge in the Complex Commercial Litigation Division of the Delaware Superior Court under the Chief Justice's Standing Order.

Step 3: Identify plaintiffs' counsel.

Step three prompts users to identify the plaintiffs' attorneys. If the filer is self-represented and has an FSX account, then the filer will select the filer's own name.

The court knows that in some complex cases, multiple firms represent plaintiffs. In Step 3, filers should first enter information concerning the attorneys from the Delaware firm that is handling the filing. Note that, when listing counsel authorizing the filing, filers will be permitted to identify any Delaware attorney in their firm who is signed up for FSX. Filers can then enter information for additional attorneys involved in the action. Filers can list all additional attorneys—including non-Delaware attorneys—as “additional counsel.” Listing additional counsel is optional. Listing an attorney as additional counsel helps the court screen for potential conflicts when assigning the case to a judicial officer. Listing an attorney as additional counsel does not substitute for an entry of appearance or pro hac vice motion for that attorney nor result in that attorney receiving e-filing notifications in the new action.

Step 4: Enter related-case information.

If a new action is related to a pending matter in the Court of Chancery or another Delaware court, the Chancellor may assign (or request approval from the Chief Justice to assign) the new matter to the judge presiding over the pending matter. For this purpose, only, the court defines “related matter” as a matter that (i) arises from the same factual predicate or transaction and (ii) involves overlapping entities or parties.

Step 5: Enter subject matter jurisdiction.

The Court of Chancery is a court of limited jurisdiction and plaintiffs are asked to identify the statutory basis for jurisdiction when filing a new matter. This representation aids the court in the administration of justice and informs case assignments. Although it is



not a binding representation, the court asks that the authorizing attorney take care to be accurate and complete when filling out the form. Filers should select all applicable bases for subject matter jurisdiction, and many might apply. For example, a claim for breach of contract under Section 111 of the DGCL might also seek equitable relief. In that circumstance, a filer might check both 8 Del. C. § 111 (Interpretation or Enforcement of a Constitutive Document, Other Corporate Instrument, or Enumerated Agreement or Instrument) and 10 Del. C. § 341 (matters and causes in equity).

Filers can query the universe of potential bases through key word searches. To aid in that process, the total universe of options appears below.

Step 6: Indicate if the action is a summary proceeding or if the filer seeks expedited proceedings.

Step 6(a): Indicate if the action is a summary proceeding.

Some actions filed in the Court of Chancery are designated summary by the authorizing statute, such as 8 Del. C. §§ 145(k), 205, 211(c), 220, 225, or comparable alternative entity statutes. The court aims to resolve those matters promptly unless the filer states that the plaintiff is not seeking expedition.

For filings initiating summary proceedings, the filer must check the box to indicate that the complaint initiates a summary proceeding. If the filer checks the box, the



filer must upload a motion to expedite with a proposed scheduling order or a letter stating that the filer does not seek an expedited schedule.

Step 6(b): If the action is not a summary proceeding, indicate if the filer seeks expedited proceedings.

If a filer seeks expedited treatment of an action that is not a summary proceeding, the filer must check the box indicating that the complaint is accompanied by a motion to expedite and possibly one of the following: a motion for a temporary restraining order; a motion for a preliminary injunction; or a motion for a status quo order. After checking the box, the filer will be prompted to select the documents that will be uploaded. The filer must then upload the additional documents before finalizing the transaction.

For cases filed under 10 Del. C. § 348, which are expedited by statute, the filer must still check the box indicating that the complaint is accompanied by a motion to expedite. But the filer must upload, in the place of a motion to expedite, a certification that the case is eligible to receive expedited treatment as required by Rule 174(c)(2).
