<b>Add the Initiating Party (IP):</b> <ol style="list-style-type: none"><li>Select Initiating Party.</li><li>Select <b>Petitioner</b> as the Party.</li><li>Select <b>Organization</b> as the Entity.</li><li>Enter <b>State of Wyoming</b> as the Name.</li><li>Choose the <b>authorizing attorney</b>.</li><li>Select <b>Attorney in Charge</b> as the Type.</li><li>Click <b>Save Party</b>.</li></ol>	<b>Add the Initiating Party (IP):</b> <ol style="list-style-type: none"><li>Select Initiating Party.</li><li>Select <b>Plaintiff</b> as the Party.</li><li>Select <b>Organization</b> as the Entity.</li><li>Enter <b>State of Wyoming</b> as the Name.</li><li>Choose the <b>authorizing attorney</b>.</li><li>Select <b>Prosecutor in Charge</b>.</li><li>Click <b>Save Party</b>.</li></ol>

<b>Add the Initiating Party (IP):</b> <ol style="list-style-type: none"><li>Select Initiating Party.</li><li>Select <b>Petitioner</b> as the Party.</li><li>Select <b>Organization</b> as the Entity.</li><li>Enter <b>State of Wyoming</b> as the Name.</li><li>Choose the <b>authorizing attorney</b>.</li><li>Select <b>Attorney in Charge</b> as the Type.</li><li>Click <b>Save Party</b>.</li></ol>	<b>Add the Initiating Party (IP):</b> <ol style="list-style-type: none"><li>Select Initiating Party.</li><li>Select <b>Plaintiff</b> as the Party.</li><li>Select <b>Organization</b> as the Entity.</li><li>Enter <b>State of Wyoming</b> as the Name.</li><li>Choose the <b>authorizing attorney</b>.</li><li>Select <b>Prosecutor in Charge</b>.</li><li>Click <b>Save Party</b>.</li></ol>

<b>NOTE:</b> For Abuse & Neglect cases, add the minor, then use the Additional Party option to add parties with allegations as "Respondents."	<b>NOTE:</b> Do not add any other parties in FSX. Clerks will add additional parties to the case management system.
